



AVIATOR WEBSITE REGISTRATION USER ID AGREEMENT

An Aviator User Identification (User ID) is required by any party seeking access to the Aviator web sites. To register, complete this form and submit it to Columbia. Upon approval of your registration, Columbia will email you on behalf of the Registrant, the User ID and help you establish a password. Under certain circumstances, described below, an Access Code will be provided to you to view invoices electronically. You and Registrant agree to comply with terms and conditions of other applicable Columbia Gas Agreements regarding access to and use of information provided on or through the Aviator web site, including but not limited to the Aviator Web Site Access Agreement, which can be located at <https://www.nisourcesuppliers.com/>

AVAILABLE SCOPE OF ACCESS

The NOMS User ID of a Natural Gas Customer, Natural Gas Marketer, and Natural Gas Shipper will have access to nominate transportation volumes on assigned contracts.

The GTS RPTS User ID of a Natural Gas Marketer shall have access to reports related to Gas Transportation accounts.

The CONCERNS User ID of a Natural Gas Marketer shall permit access to concerns submitted on behalf of CHOICE Program customers.

The GTS BILL/VIEW Access Code provided to Natural Gas Customers and Natural Gas Marketers will grant electronic access to their respective invoices.
