Upon approval of your registration, Columbia will e-mail you a Master ID and help you establish a password. With that Master ID and password, you will be able to access information on the web sites. You will also be able to assign User IDs for others in your company. Under certain circumstances, described below, you may also be able to make payments on the web sites. AVAILABLE SCOPE OF ACCESS

The Master ID and User IDs of a Natural Gas Customer shall permit access to account information via the Aviator website about that Natural Gas Customer.

The Master ID and User IDs associated with a Natural Gas Marketer permit access to account information via the Aviator website about those Natural Gas Customers associated with such Master ID and User IDs.

Natural Gas Customers may elect to make payments via the Aviator web sites. Natural Gas Marketers may also have access to make such payments on behalf of their respective Natural Gas Customer.

NOTIFICATION OF A CHANGE IN MARKETER (Appointment of Agent)

To authorize a Natural Gas Marketer to access information, or to terminate such access, a Natural Gas Customer must complete and submit an Appointment of Agent form to Columbia available at <https://www.columbiasuppliers.com/>.

The Appointment of Agent form is effective when received, accepted, and processed by Columbia. If the change in appointment should be delayed until some future time, please so indicate on the form.

The Natural Gas Customer must inform the outgoing Natural Gas Marketer that Natural Gas Marketer will no longer have access to any of the Natural Gas Customer's information. This includes not having access to the PSID, the permanent 9 digit service ID number found on the Gas Transportation Invoice. The outgoing Natural Gas Marketer must ensure it has retrieved as of the effective date of the change all necessary information from the web site. After access is terminated, the outgoing Natural Gas Marketer must obtain this information from the Natural Gas Customer directly.

RESPONSIBILITY FOR ADDITIONAL ACCESS TO INFORMATION

Upon approval, Columbia will provide a Master ID to Registrant. Registrant, and not Columbia, is solely responsible for granting any additional User IDs. Registrant, and not Columbia Gas, is solely responsible for any action taken by the users of such additional User IDs. If Registrant is a Natural Gas Customer, it, and not Columbia, is solely responsible for any actions taken by its appointed agents.

Columbia shall have no responsibility whatsoever for administration or monitoring of Registrant's Master ID or any user ID that Registrant issues.



Columbia shall have no responsibility for the failure of Registrant or any party granted a User ID by Registrant to comply with the terms and conditions of this Agreement. Registrant shall indemnify and hold harmless Columbia for any and all losses, costs, expenses and charges, in whatever form and of whatever nature, arising out of Registrant's failure to comply with the terms of this Agreement as well as any negligence or misconduct in the access, use and administration of or by its User ID(s).
