<u>Gas Transfer Service</u>: Gas Transfer Service: This is an optional service available to each Customer, and/or Its Agent, taking service under Rate Schedules TS1/TS2, L VTS, or AS that has subscribed to the Company's Banking and Balancing Service or that uses Columbia's Cash-Out Option. This service provides for the transfer of gas quantities from one Customer/Agent ("transferor") account to another Customer/Agent ("transferee") account on any day, including days when a BSR is in effect, but excluding days when an interruption or curtailment is applicable to a proposed transferee, and in accordance to guidelines listed on Original Sheet No 163 of the Columbia Gas of Virginia Tariff. Gas Transfer Requests must be submitted by 5:00 P.M. Eastern time on the third business day following the end of the applicable calendar month. The company will charge the transferor (Customer or Agent) a flat fee of \$5.59 per transaction for Daily Gas Transfer Service.
